

### **ENDOWMENT GIFT AGREEMENT**

I/We The Donor, have identified the Signature Foundation Inc., a registered foundation in the Philippines under Securities and Exchange Commission, SEC REG.NO: CN201732026 to receive an amount of \_\_\_\_\_

#### **I. Purpose**

This endowment gift named, HEAVEN'S TREASURE, shall be used for the Projects and Programs operated by the Signature foundation. Investment Returns from this endowment will be used for Feedings, Scholarships, Medical Assistance, Retreat Sponsorships, Community and Campus Outreaches, Tree Plantings, Constructions, and other operational expenses run by the foundation.

#### **II. Administration**

This endowment gift may be merged or commingled with other funds held by the Signature Foundation for investment purposes in accordance with the policies of the Board. In connection with administration and management of the endowment funds, and in order to support development efforts to enhance the institutions philanthropy, the Board may authorize allocations against the endowment.

#### **III. Investment**

The fund is managed by investment, with the goal of preserving the principal amount and generating income to support the Foundation Projects and Programs. Earnings and Returns from the invested Fund may be retained and expended for the purposes of the endowment in subsequent years, or may be reinvested, at the discretion of the Board, as a permanent addition to the principal of the endowment.

#### **IV. Irrevocable Gift**

The Donor decides this endowment fund to be irrevocable or permanent. This emphasizes the gift's permanent nature, with the principal amount preserved and invested to generate income in perpetuity. The gift is a lasting, committed contribution that cannot be withdrawn or altered by the donor. (NOTE: OR THE DONOR CAN CHOOSE A 'TERM ENDOWMENT' in which his full given amount will be returned in an agreed number of years like after 5,10, or more years without any dividends or interests). Also, the Donor may make additional gifts to the Fund at any time.

#### **V. Recognition**

In recognition for this endowment gift, the Foundation agrees an endowment report on the fund IF REQUESTED. The Donor will also receive a Certificate and Token of Recognition for the invaluable support to the humanitarian works of the Signature Foundation. Recognition events may be also organized.
